

# **Aztec Group selected to administer Deutsche Private Equity's €1bn Fund IV**

**We've been appointed to administer Deutsche Private Equity's ("DPE") €1bn Fund IV ("the Fund").**

Established in 2007 and with more than €2 billion of assets under management, DPE is an independent German investment company that predominantly invests in small and medium-sized companies based in Germany, Austria and Switzerland.
